Terms and Conditions

Coaches Code of Conduct

Purpose: This Code of Conduct has been developed to clarify and distinguish approved and accepted professional, ethical and moral behavior from that which is detrimental to the development of soccer within the Club. Punishments for violations of this Code of Conduct may be imposed upon a Coach by the League.

Responsibilities to Players

1. Coaches shall never place the value of winning over the safety and welfare of players.
2. Coaches shall instruct players to play within the laws of the game and within the spirit of the game always.
3. Coaches shall not seek unfair advantage by teaching or encouraging deliberate unsportsmanlike behavior to players.
4. Coaches should not tolerate inappropriate or unsportsmanlike behavior at Games or Training Sessions from players or adults regardless of the situation.
5. Coaches shall not place demands on a Players' time so extensive as to interfere with academic goals or progress.
6. Coaches should direct Players to seek proper medical attention for injuries and to follow the physician's instructions regarding treatment and recovery.
7. Coaches should take an active role in educating their Players about sports nutrition, fitness and about prevention of tobacco use.
8. Coaches should educate themselves on a constant basis to provide their Players with the highest-level instruction possible.
9. Coaches should always place the Player's development first and place Team success second.

Responsibility to Referees

1. Referees must have the support of Coaches, Players and spectators. Coaches must always refrain from criticizing Referees in the presence of Players or spectators.
2. Professional respect, before, during and after the Game, should be mutual. There should be no demeaning or threatening dialogue or gestures between Referee, Coaches or Players.

Code of Conduct

I pledge to be responsible for my words and actions while participating in a youth sports event and shall conform my behavior to the following code of conduct:

- I will not engage in unsportsmanlike conduct with any coach, parent, player, participant, official, or any other attendee.
- I will not engage in any behavior which would endanger the health, safety, or well being of any coach, parent, player, participant, official, or any other attendee.
- I will not use drugs or alcohol while at a youth sports event and will not, nor will I attend or participate in a youth sports event while under the influence of drugs or alcohol.
- I will not engage in the use of profanity, nor engage in verbal or physical threats or abuse aimed at any coach, parent, player, participant, official, or any other attendee.

I also agree that if I fail to conform to the Code of Conduct while attending or participating in a youth sports event, I will be subject to disciplinary action, including but not limited to the following in any order or combination:

- Verbal warning issued by an official, head coach, or head of league organization.
- Written Warning
- Game suspension or immediate ejection from event with written documentation of the incident kept on file by organization involved.
- Suspension from multiple events.
- Game forfeit determined by official or coach.
- Season suspension or multiple season suspension issued by a league organization.

Personal Release Statement

- I understand that the registered activities and services may have an element of hazards or inherent danger.
- I take full responsibility for my own and any child's action and physical condition.
- I agree to indemnify and hold the Organization, its employees, and the Sponsors HARMLESS from any liability loss, cost or expense (including attorney fees, medical, and ambulance costs) that may incur while participating in the Organization.
- I further understand that while participating within the Organization, media coverage may be used to highlight public participation.
- I give my consent for the Organization to use photographs and/or video (the Property) for advertisements and I understand that the Organization is not obligated to use or exhibit the Property.
